5 Response to Motions to Dismiss:

7 Plaintiff representing himself and those likewise who have been wrongfully
8 tortured and murdered by those we are forced to trust in this culture restates
9 the following assertions because the responses from the powers that be have
10 been to date lacking any indication that they realize the gravity of the
11 complaint. The only person that should be dismissed in this just cause is
12 Lori Frank Joy, a case of mistaken identity of the murderer on the loose at
13 Deaconess Medical Center, James Joy.

15 In Response to the Attorney General's office in the State of Washington:

16 My first thought was," Have the powers that be gone completely insane?!" I
17 am sacrificing EVERYTHING including putting my very life in grave peril
18 to notify the proper authorities of serious crimes. At first I thought when I
19 notified the local police departments that they hadn't gotten my complaints,
20 but then I found out they had. I then notified the attorney generals that the

21 local authorities did not want to investigate my allegations. When no
22 response came, not even a phone call, I thought perhaps they didn't get my
23 complaint either. I tried multiple faxes and even U.S. mail to alert the
24 powers that be that local authorities did not even want to try and investigate
25 allegations of attempted homicide. Granted it's not the typical way you hear
26 about murder but it is nevertheless absolutely a way to murder someone and
27 I can prove the attempt. So now when I finally know that I've contacted and
28 they have read my complaint, the official response is to charge me money
29 for trying to save other citizens lives! I really hope they don't really intend
30 that. I will make this very simple, physicians and physicians assistants at
31 Deaconess Medical Center tried to murder me and I can prove it, but I need
32 the State to conduct a formal investigation with medical experts to explain
33 the evidence I have because it is obvious to me now that no one is just going
34 to take my word for it; even though it is convincing and factual, it involves
35 specific medical knowledge that I happened to have acquired in my life
36 experience but is not common public knowledge. Then other physicians in
37 Idaho have systematically helped to cover up these criminal activities and
38 other "victims" at NIBH assured me that mental wards regularly covered up
39 "medical malpractice" not just in this state but in others as well by giving
40 disreputable diagnoses and harmful psychotropics to "victims" of these

41 unbelievable crimes. This is the reason I started the complaint in
42 Washington, because that is where the crimes began, but have continued in
43 Idaho. I requested that since it has crossed state lines that it be tried in one
44 Court here in Idaho. I have not been trying to waste my money time and
45 resources on anything frivolous; I simply have not been able to comprehend
46 why murder is of not of enough importance for local or state officials to
47 even pick up a phone to investigate. If the attorney general's office would
48 help me save lives and begin a criminal investigation now, I would gladly
49 drop my complaint against them for not doing so. Again, the only reason I
50 included them was no one responded by phone call or in anyway to all my
51 previous attempts. Now that I know these offices are actually receiving my
52 mail; please help me save lives. I reiterate, the only reason, I included the
53 state attorney generals in both states in this action is neither office responded
54 to any of my previous attempts to instigate a criminal investigation. In fact,
55 with no response from local or state officials (when it is their described
56 duties to prosecute criminal complaints and when local authorities don't
57 investigate, I had to notify superior officials) and under the circumstances I
58 wasn't even sure any local, state or federal officials had gotten my
59 complaint. I STATE AGAIN THAT I NOTIFIED PUBLIC
60 AUTHORITIES ON A LOCAL, STATE AND FEDERAL LEVEL AND

61 NOT EVEN ONE PHONE CALL TO INVESTIGATE ALLEGED
62 HOMICIDE ATTEMPTS! Now that I know you are getting mail, please
63 help rectify this tragedy immediately.

65 I state the same to the attorney general's office for the State of Idaho.

66

67 I state the same to the United States federal authorities. An investigation
68 needs to be conducted not only for why murder is crossing state lines in
69 hospitals and mental wards by keeping the public in ignorance of the many
70 ways to murder with medical knowledge and the use of approved
71 medications/poisons with LETHAL side effects; but why the public has been
72 kept in perilous ignorance of a rather common genetic trait that results in all
73 kinds of serious ailments. That genetic trait wrongly being called rare is also
74 wrongly being called a disease; specifically, "Wilson's Disease". I have
75 surmised that suffering and death is highly profitable and is in keeping with
76 eugenics philosophy to keep us all in ignorance. It is only a hypothesis
77 based on more and more evidence that I've gathered over the prolonged
78 period of being unable to obtain so much as a phone call from local, state,
79 and federal executive offices to investigate my allegations.

81 I hope that the U.S. Attorney General's office will also rectify that stance
82 immediately, so that our lives are actually protected by our laws and tax
83 payer provided public servants instead of persecuted by them.

84

85 To Regina Danielsson I reply that I am not trying to cost her money and in
86 my request for remedy, I sought criminal consequence should I perish but to
87 speak from my inmost being that is not what I'm after. What I want for
88 everyone is to simply not be discriminated against especially in matters of
89 life and death such as healthcare. My excruciatingly painful question to her
90 (and to our national policies thereby) is, "How can it be illegal to
91 discriminate in our public schools and accommodations such as restaurants
92 and hotels, but not in medical practice?! – that is in matters of LIFE AND
93 DEATH?!" How can she or anyone with good conscience say to one
94 citizen that she'll help them live and be in good health and to another that
95 they can just go on and suffer or die. To this date Ms. Danielsson has
96 provided no reason whatsoever for refusing me medical care and has
97 wrongly involved a local officer in her discriminatory practice against me.

98

99 I know the Westbrooks simply got involved with something they had no idea
100 about; so I'm not looking to see them punished; I simply want people to

101 understand that just because something is not a common event or
102 happenstance; doesn't mean it isn't true. They were skillfully manipulated
103 into participating in this whole event because it is rather unconscionable that
104 professionals we trust would commit serious crimes; so they simply chose to
105 disbelieve my allegations as well. I don't mind skepticism, but historical
106 and current evidence provides that my allegations could well be true as they
107 have happened and are happening not only in this country but others as well.
108 It is an unfortunate fact that human psychology will often punish victims of
109 serious crimes due to willful unbelief in order to preserve their own sense of
110 false security. It is not ultimately in the public's best interest to go on
111 disbelieving eye witnesses that come forward of serious crimes to their own
112 peril and detriment.

113

114 It is my ultimate motive in all of this complaint simply to save lives and
115 ensure others do not go through the hell I've been through and unfortunately
116 am still enduring as I have yet been unable to persuade any righteous
117 authorities to investigate not only my eyewitness testimony that I am willing
118 to take a polygraph for, but the actual hard evidence I have kept to prove
119 these allegations. It is my intention hopefully to miraculously regain good
120 health and return to being a productive member of society. It is also my

121 intention that security cameras be set up to protect people during any
122 medical procedures; especially ones where the patient must be unconscious
123 or in the event of long term care, during restful sleep. It is dangerous to
124 assume that all medical personnel are decent citizens when historically and
125 currently there have been those busted for murder by poisoning, overdoses
126 and suffocation to name just a few and even in this country and others there
127 have been those busted for “organ harvesting”. There are many reasons why
128 people murder but some of the motives are simply as base as sadism or what
129 has been established during criminal investigations for physicians who have
130 been busted for murder in the past is they develop a “god complex” where
131 they are stimulated by the power of life and death. These are documented
132 facts, but everyone wants to think it only happens in other states or other
133 countries; never in their local jurisdiction even when someone actually
134 survives the attempt and states so plainly that it is! I don’t really know why
135 they tried to murder me, I just know they did and that my health has been so
136 severely compromised that I am still in danger of dying from the attempt. (I
137 am certain that an expert hematologist could determine that my overall
138 health and welfare is at extreme risk due to the fact that nothing has been
139 done to help me after having been given three units of incompatible blood,
140 but so far I have not been able to find such a person).

141

142 On a personal level, so far I've sacrificed my career to try and alert people to
143 the danger of these criminals on the loose and my marriage has been strained
144 to put it mildly, my dog has been shot and while I'm struggling for my life,
145 suffering more severely than most can imagine all I've gotten for my efforts
146 so far is mockery, disbelief and hardship as paid public servants won't even
147 take a small moment to call me, talk with me and attempt to document the
148 evidence I've gathered in my intense effort to save even one other person
149 from this hell on earth. My adoptive parents are elderly one is in severe pain
150 of bursitis and the other has developed early stage Alzheimer's. My
151 adoptive mother has expressed a desire to have me come visit, but I can not
152 do so because I'm here desperately fighting to save even one soul from the
153 horrors I've experienced. Even if I wanted to visit, I'm not sure I could do
154 so due to my present health challenges brought on from these crimes. In
155 addition, I've been left so severely disabled that I'm in danger of dying from
156 homelessness as I have yet to be able to even apply for disability due to the
157 fact it is taking quite some time to get a notarized copy of my birth
158 certificate. As a result of my inability to work due to the crimes against me
159 and how difficult it has been to recover my health, I have resigned to give
160 my best effort that these horrible circumstances don't befall someone else

161 simply because I didn't try to stop them; but I do need help as I'm simply so
162 ill, it is getting increasingly difficult even to make it out of bed, let alone into
163 town. I always thought if a citizen witnessed a crime we were supposed to
164 report it and an investigation would ensue, instead not even a phone call was
165 made to find out what evidence I had of my serious allegations!

166

167 Please don't let it be the response of public officials sworn to serve and
168 protect to actually punish a person for attempting to report serious crimes by
169 asking me to pay you on top of the tax money you all get to do your jobs that
170 you have all been avoiding for some reason I can't even fathom, except that
171 you're so unwilling to think that murderers could be working in local
172 hospitals. It is not for your safety and that of your friends and family that
173 you won't even take the time to call me in your skepticism to see what proof
174 I can present to back up my allegations. It is dangerous to be so fantastical
175 in your own thinking that these professionals simply couldn't do what I'm
176 stating emphatically that they have that you actually let them go free in your
177 unwillingness to legitimately investigate these matters as all the officials to
178 this date have that I have contacted.

179

180 I say again, to the powers that be, the state and federal attorney generals,
181 PLEASE HELP ME SAVE LIVES! I am very ill and I need assistance
182 organizing all the evidence, please call me soon and as a citizen I will do my
183 part, but I need you please to care enough about quality of life in America to
184 perform the duties of your office. Again, PLEASE HELP ME SAVE
185 LIVES! There is no way homicides should be taking place in hospitals
186 when a citizen goes there willing to pay for their health; not murder and
187 torture as is occurring locally. I can understand skepticism, but why not one
188 public official has even called to ask me what proof I have of these serious
189 crimes has me weeping with grief on top of my physical pain and suffering.
190 PLEASE HELP ME HELP OTHERS AS SOON AS YOU POSSIBLY
191 CAN!

192

193 The hospitals need to install cameras in all locations to ensure these crimes
194 don't occur and not impede criminal investigations by hiring expensive
195 attorneys simply to protect public reputation rather than genuinely ensuring
196 public safety and earning that trust. Real criminals are still at large in these
197 named hospitals of my complaint and they must be stopped before more
198 wrongfully die. This case is serious and must not be dismissed prior to
199 evidentiary hearing.

200 Personnel at urgent care may have been contacted by other defendants and
201 so their testimony is equally important. In addition, Dr. Hernandez seemed
202 to be the only professional in the region that was aware that “Wilson’s
203 Disease” is far more common than is widely presumed, his testimony is
204 important.

205

206 People’s lives and welfare are more important than money.
